### 1.0 OVERVIEW

This document will serve as the selection document for the **2022 Canada Summers Games Team** in Niagara, ON for the para throws athletes. Athletes and coaches are asked to familiarize themselves with this document. All selections will be made in accordance with these criteria. This information will be used by BCWSA during the published team selection process.**

### 2.0 GENERAL INFORMATION

#### 2.1 Funding

BC Wheelchair Sports Association and the Sport Branch of the Provincial Government will provide support to qualifying athletes.

## 2.3 Team Information

### a. Team Size and Events

Maximum of 2 para throws athletes (minimum 1 male and 1 female) will be selected to compete in the events of shot put and discus.

- It should be noted that the 2 athletes competing in the para throws events **must be different** than those athletes competing in the wheelchair track events.

### b. Team Age

All Para-Athletics Classifiable athletes must be under 37 years of age as of December 31, 2022 – born 1986 or later.

### c. Classification

Para Throwing events are open to all throwing classifications with results being calculated through the WPA Points Scoring Tables or equivalent available in 2022. Males and females will not be combined. Males and females will not be combined and able bodied competitors cannot be entered in Para-Athletics events. Athletes must have a minimum of a provisional classification at the time of their submitted results for those performances to be considered.

### d. Team Travel

Team BC will be arranging travel for all Team BC athletes, departing from Vancouver YVR on August 14, 2022 and returning to Vancouver YVR on August 22, 2022. BCWSA will make arrangements for athletes outside of the Lower Mainland to travel to and from YVR for their departing and returning flight. If travelling to or from the Canada Summer Games from a location outside of British Columbia, athletes must notify the BCWSA Program Coordinator to make alternate travel arrangements.

### e. Team Accommodations

The Canada Summer Games will make all arrangements for accommodations for all Team BC athletes and staff.

## 2.4 Eligibility

For athletes to be considered for selection to Team BC, they must meet all of the criteria listed below:

- Athletes must be members in good standing with BC Athletics and their respective Disability Sport Organization (BC Wheelchair Sports Association) at the time of qualification and must remain in good standing until completion of the 2022 Canada Summer Games.
- The Team BC age classification for all Para-Athletics Classifiable athletes must be under 37 years of age as of December 31, 2022 – born 1986 or later.
- Athletes must meet BC residency guidelines as outlined in Section 3.4 Residency of the 2022 CGC Athlete Eligibility Policy [2022 Canada Games Council Games Policy and Procedures](#).
- Excluded from the Canada Games are:
  - Senior National Team Members - Defined as: Athletes who have held an SR, SR1, SR2 or C1 card at any time; and/or athletes who are part of (on the roster of) a standing Senior National Team (i.e. recognized as a Senior National Team member regardless of event participation)

- b. Athletes who have previously competed at the following events:
  - i. WPA/WA World Championships
  - ii. Olympic/Paralympic Games
  - iii. Pan Am/Parapan Am Games
  - iv. Commonwealth Games
- e. Compete in at least one contested Canada Summer Games event (discus and/or shot put) in a sanctioned competition during qualification period (March 1<sup>st</sup> – July 10<sup>th</sup>, 2022).
- f. Submit an [Athlete Declaration Form](#) prior to the published declaration due date.

## 2.6 Selection Criteria

Qualifying period will be held from March 1 to July 10th, 2022.

- a. Athletes who intend to participate in Canada Summer Games in para throws must complete the [Athlete Declaration Form](#) prior to the published declaration due date – July 10<sup>th</sup>, 2022.
- b. Athletes must compete in discus and/or shot put at a minimum of two sanctioned meets during the qualifying period. A meet must be provincially, nationally, or internationally sanctioned from an appropriate PSO or Athletics Canada.
- c. All performances must appear on the [2022 Outdoor Athletics Canada Ranking System](#). It is the responsibility of the athlete to submit eligible performances to Athletics Canada in order to be considered for selection. Please submit results to [results@athletics.ca](mailto:results@athletics.ca).
  - \*Meet selection is at the discretion of the athlete, however, only results from sanctioned meets will be used for selection purposes.
- d. Athletes who were unable to compete in a sanctioned competition for reasons listed below will have performances from 2021 considered relative to the selection criteria. Notification to Jessica Ferguson ([jessica@bcwheelchairspots.com](mailto:jessica@bcwheelchairspots.com)) on the inability to compete within the qualification period is required prior to July 10<sup>th</sup>, 2022.
  - **Exemption 1: Competing on a Canadian Team at an International Competition and/or Training Event** – proof of requirement to participate in National Team competition/training event must be submitted (ex. YTP with identified meets from personal coach, emails from National Team staff, etc.)
  - **Exemption 2: Injury or Illness** – Provincial coaches must be notified prior to the start of the competition/clinic and a letter from a medical doctor may be required.
  - **Exemption 3: Extenuating Circumstances** – Defined as a personal or family tragedy, incident or emergency that does not allow an athlete to attend the Team BC Selection Trials, or accept selection to a BC Team. Notification must be made to the BCWSA Program Coordinator as soon as it is possible to do so.
  - **Exemption 4: Education, Exam, or Graduation Commitment** – A schedule indicating classes, exams, or graduation ceremony must be submitted.
- e. An athlete's top three performances in both shot put and discus events during the qualifying period will be used for the selection. At the conclusion of the qualifying period, these distances will be scored using the Athletics Canada Points Scoring Tables (or equivalent available). An average for an athlete's shot put and discus results will be calculated.

- f. The athletes will be assessed by BCWSA's Provincial Team Coach and Program Coordinator based on their results, their attendance at BCWSA track and field practices (and/or equivalent practices within local track clubs), and their stage of the LTAD model as determined by the Provincial Team Coach and Program Coordinator.
- g. Other athletes may be considered from published results, ability to fill minimum team allocations, and medal potential if results were achieved during the qualification period (March 1<sup>st</sup> – July 10<sup>th</sup>, 2022). Priority will be given to athletes who meet all the above selection criteria.
- h. Final Team BC selection will be announced on or before July 12<sup>th</sup>, 2022 and all athletes must complete their online registration profile no later than July 23<sup>rd</sup>, 2022.

### **3.0 AMENDMENTS**

BC Wheelchair Sports Association reserves the right to amend this document at any time up to the Selection Date for changes imposed by parties external to BC Wheelchair Sports Association, or for changes that, in the opinion of BC Wheelchair Sports Association would improve or enhance the selection process.
